1. I understand and acknowledge that the activities I or my child engage in while on the premises of A-Towne Athletics Elite LLC., pose known and unknow risks which could result in injury, paralysis, death, emotional distress, or damage to me, my child, on property, or to their parties. The following describes some, but not all of those risks.
2. Cheerleading/Gymnastics, including performances of stunts, tumbling, and any activity on the property, entail certain risks that simply cannot be eliminated without jeopardizing the essential qualities of the activity. Without a certain degree of risk, athletes would not improve their skills and the enjoyment of the sport would be diminished. Cheerleading/Gymnasticsexpose participatnts totheusual risk of cuts, bruises, and other risks as well. Participants may fall,sprain or break wrists/ankles, and could suffer more serious injuries. Traveling to/from competitions, meets, and exhibitions raises the possibilities of any manner transportation accidents/in any event, if you or your child is injured, medical assistance may be required which you must pay yourself.
3. I expressly agree and promise to accept and assume all the risks, known and unknown, connected with A-Towne Athletics Elite LLC. relative activities, including but not limited to performance of stunts and use of trampolines and tumbling equipment. My participation and that of my child is purely voluntary. No one has forced or coerced me or my child to participate. I elect for myself and my children to participate in such activities despite the risks.

4. I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify A-Towne Athletics Elite, LLC. from any and all liability, claims, demands, actions or rights of action, which are related to arise out of or are in any way connected with my child's participation in A-Towne Athletic Elite, LLC. related events and/or activities.
5. Should A-Towne Athletic Elite, LLC. be required to incur attorney's fees and cost to enforce this agreement, I agree to indemnify and reimburse them for such fees and costs.
6. I certify that my child has healthy, accident and liability insurance to cover bodily injury or property damage that may be caused or suffered while participating in the event or activity, or else I agree to bear those costs of such injury or damage to my child further certify that I am willing to assume and bear all risks that may arise or be created, directly or indirectly, through or by any condition.
7. In the event that I file lawsuit against A-Towne Athletics Elite, LLC. I agree to do solely in the State of Georgia and I further agree that the substantive and procedural laws in the state shall apply in any such action without regard to the without regard to the conflict of laws rules thereof. I agree that if any portion of this agreement is found void or unenforceable, the remaining portions shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation or the participation of any of my children in this activity, I may be found by court of law to have waived my right to maintain a lawsuit against A-Towne Athletics Elite, LLC. by signing this agreement.
